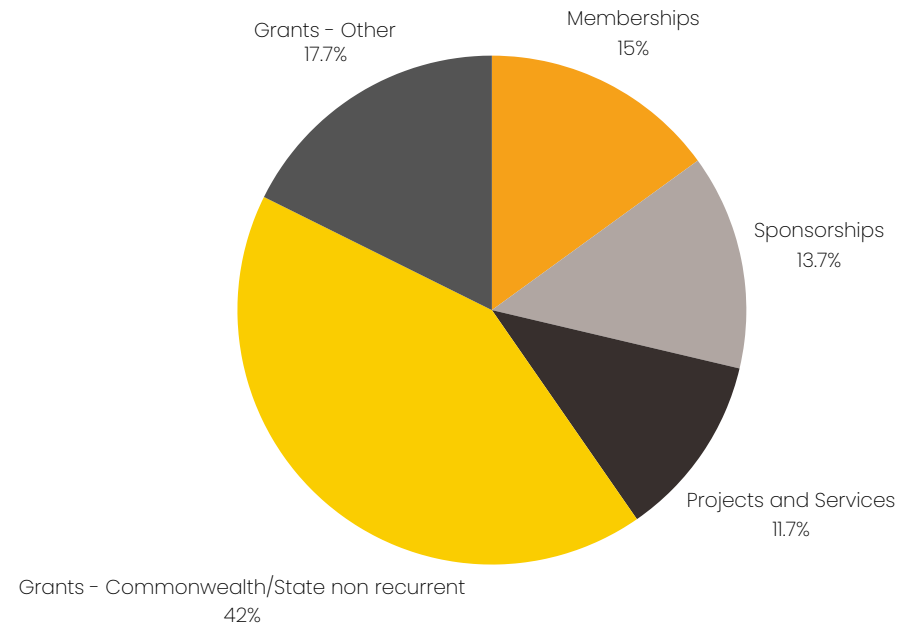
# ABOUT AFCA
